Processing purposes and legal basis:

Art. 6 I lit. a GDPR serves our company as the legal basis for processing operations for which we obtain consent for a specific processing purpose. If the processing of personal data is necessary for the performance of a contract to which the data subject is party, as is the case, for example, with processing operations necessary for the supply of goods or the provision of any other service or consideration, the processing is based on Art. 6 I lit. b GDPR. The same applies to such processing operations that are necessary for the performance of pre-contractual measures, for example in cases of enquiries about our products or services. If our company is subject to a legal obligation that requires the processing of personal data, such as for the fulfilment of tax obligations, the processing is based on Art. 6 I lit. c GDPR.

Data categories and data origin:

We process the following categories of data: general personal data (name, address). The data from the aforementioned data categories are transmitted to us by the final beneficiaries (i.e. organisers of the *talentCAMPus* projects).

Duration of storage:

For reasons of necessary documentation in the context of project funding, participant lists must be archived in accordance with our prescribed retention obligation. We will only process your data for as long as is necessary to fulfil the above-mentioned purposes. If you have objected to the processing of your personal data, the data will be deleted immediately.

Rights of the data subject:

If the legal requirements are met, you have the following rights under Art. 15 to 22 GDPR: right of access, rectification, erasure, restriction of processing and data portability. You also have the right to object to processing based on Art. 6 (1) (f) GDPR in accordance with Art. 14 (2) (c) in conjunction with Art. 21 GDPR.

Right to lodge a complaint with the supervisory authority:

In accordance with Art. 77 GDPR, you have the right to lodge a complaint with the supervisory authority if you believe that your personal data is being processed unlawfully.
